CALL FOR ABSTRACTS

Let me invite you to participate at the **9th ANNUAL CONFERENCE ON ARCHITECTURE AND URBANISM 2020**, which will be organized in a virtual form on **4th November 2020** by the Faculty of Architecture of the Brno University of Technology, Czech Republic.

The international conference will be organized for doctoral students in order to exchange experience and knowledge between research institutes and young researchers during the meeting. The conference will be organized virtually on **4th November 2020** by the Faculty of Architecture of the Brno University of Technology (FA BUT), Czech Republic. The students will present during one day the results of their research focused on the thematic scope of the conference in two areas of architecture and urban design. This year's 9th annual conference is a follow up on previous conferences held in Prague in 2011, 2014 and 2017 in Bratislava in 2012 and 2015 and in Brno in 2013, 2016 and 2019.

We are inviting you to present a slideshow presentation of 15–20 slides, a full-text of your paper 4–5 pages long (when accepted in double-blind peer review, the paper will be published in the Book of Proceedings and indexed in Google Scholar) and to virtually exhibit a conference poster (B1 size, portrait oriented), which will present the essence of the topic of your research at an accompanying virtual exhibition organized from **2nd to 8th November 2020** in an on-line gallery. We will be happy to review the full text of your original unpublished paper, after your abstract is recommended by the scientific committee.

Illustration in the range of max 1 full-page illustration - drawing, photograph, diagram,

Illustrations resolution 300 dpi width of 150 mm (jpeg),

Resource and Illustration citation in accordance with ISO 690 (author-date),

The author of the paper is responsible for ensuring the copyright and reproduction rights of illustrations included in the paper

Poster size B1 (70 cm width, 100 cm height), submitted in .pdf format (resolution 300dpi), submission deadline no later than 4th October 2020, the poster will include a label placed at the bottom edge in the horizontal strip of 5 cm height, according to the following example:

Form of presentation:

Oral presentations of 10 minutes accompanied by an image presentation (PowerPoint, pdf, jpeg). Each presentation will be followed by a brief discussion. The organizer provides a data projector and a Windows PC.

Oral presentation lasting 10 minutes accompanied by a visual presentation of slides. Each presentation is followed by a professional discussion lasting 10 minutes. The conference organizer will make the virtual conference platform available in advance, including instructions to the presenters. The organizer assumes that each presenter will give a separate presentation from their own computer equipped with a microphone, headphones and webcam, connected to the broadband Internet, at a speed of at least 1.5 Mbps (up / down). When preparing pictures, please note that the resulting paper will be printed in black and white. Insert the corresponding titles and descriptions in the appropriate places of the document in italics (see below).
